On May 10, 2013, the Indiana Brownfields Program ("Program") submitted a formal request for a Section 106 National Historic Preservation Act review to the Indiana Department of Natural Resources' Division of Historic Preservation and Archaeology. However, it has been discovered that the address provided in the request letter is incorrect for one of the parcels comprising the Site, and a new street address has been assigned. At this time, please remove the reference to 2121 W. Michigan Street and instead use 2201 W. Michigan Street. (The parcel number for 2201 W. Michigan Street is 49-11-04-028-013.000-901 (or Alternate Parcel #9054011). The 2219 W. Michigan Street address originally provided is accurate. A new Site map reflecting parcel boundaries is attached as Exhibit A-1 to this letter. This map should be used as the Site map instead of the map included as Exhibit A to the May 10, 2013 letter.
